# **Admission Requirements**

Entry requirements will be normally be a first or upper second class degree from a recognized University, in which the subjects studied include finance, accounting or economics.

Student with a first degree in a non-related subject will also be considered, but their application will need to demonstrate a very high standard ability in quantitative skills and motivation for the programme.

Relevant work experience will be an advantage, especially for applicants with a first degree in a non-related subject.

A pathway also exist through the programme that accommodates individuals with a first or good upper second class degree in a numerate discipline other than economics or finance (e.g. mathematics, a natural science or engineering).

## **Duration of the Program**

The Msc program takes two academic years. Since we operate on a trimester basis, it is possible to finish in one and half years.

## **Graduation Requirements**
